Dear Mr. LeCrone:

In accordance with the above-referenced provisions of the federal Coal Combustion Residuals (CCR) rule, Illinois Power Generating Company (IPGC) is providing the following notices regarding Ash Pond No. 2 at the Coffeen Power Station:

- 1) notice of intent to close (per 40 CFR § 257.102(g)) Coffeen's Ash Pond No. 2, an inactive CCR surface impoundment as defined by the CCR rule. In accordance with 40 CFR § 257.102(g), enclosed with this notice letter is written certification by a qualified professional engineer that the design of the final cover system (as required by 40 CFR § 257.102(d)(3)(iii)) for this CCR unit meets the requirements of 40 CFR § 257.102.
- 2) notice of availability of the initial written closure plan for Coffeen's Ash Pond No. 2.

This notice of intent to close the Ash Pond No. 2 and the initial written closure plan for this CCR unit were placed in the facility's operating record on November 18, 2015. IPGC initiated closure of each of this CCR unit on that date by taking steps necessary to implement the CCR unit's initial written closure plan. This initial written closure plan may be amended when detailed engineering has been completed. This notice of intent and the initial closure plan will be placed on our website at <https://ccr.dynegy.com/document.aspx> within the next 30 days.
